The purpose of this community recreation access agreement is to provide a clear understanding to the community as to when they can access the outdoor fitness equipment and fields at Palomares Academy of Health Sciences

Pomona Unified School District is committed to the education and well-being of its student's staff, and faculty. The use of the Palomares Academy fields and outdoor fitness equipment should be in compliance with the Pomona Unified School District's Facility Use Manual.

Pomona Unified School District is committed to **Respect**, where all students, parents, staff, and community members are all valued partners; **Responsibility**, where everyone is accountable for what they say and do; and **Results**, which reflect a high level of student achievement.

Access to Field and Outdoor Fitness Equipment

Palomares Academy outdoor fitness equipment will be open to the community after school hours, weekends and holidays.

After school is defined after the students' instructional day, and when it does not interfere with official school activities.

Weekends – Saturdays and Sunday, if no official school activities.

School Holidays, if no official school activities.

If school sites and/or facilities are under construction or repair, fields may not be available due to safety issues. This decision will be at the sole discretion of the Pomona Unified School District Administration.

Priorities for Usage

Palomares Academy students and/or faculty have priority for outdoor fitness equipment use during school hours.

Community members have priority for outdoor fitness equipment and field use during non-school hours as specified on page one (1) of this document.

Conduct of Field and Facility Users, Attendees, and Guests

- All rules and regulations of the Board of Education, the Education Code provisions established by the State and the Administrative Procedures of the Pomona Unified School District are to be observed strictly by those using school property and facilities. Any departure from the rules and regulations must be authorized by the Board of Education, and shall be exceptions only for those specific instances.
- If using a facility at a school, your activity must not begin until ½ hour after students from the school have been dismissed for the day. Youth attending your activity must not be left unsupervised while they are waiting for the activity to begin.
- Expectations for the conduct of facility users of Pomona Unified School District facilities is very high. This includes students, coaches, parents, guests, by-standers and anyone attending or using a facility. The following list includes examples of behavior that is prohibited while using equipment at Palomares Academy or accompanying someone who is utilizing the outdoor physical fitness equipment and/or fields.
 - Poor sportmanship
 - Profanity
 - Physical or verbal fighting
 - Physical or verbal abuse
 - Disrespectful behavior toward children, referees or coaches
 - Sexual harrassment or sexual misconduct
 - Gambling
 - Use of tobacco, alcohol, and drugs is strictly prohibited on all Pomona Unified School District property including parking lots, fields, buildings, sidewalks, and boulevards and surrounding the District property
 - Urinating on Pomona Unified School District propert or in beighboring property

- Entering neighboring property without permission to retrieve a misguided ball. You must contact the neighbor and obtain permission to enter their property or request their help in retrieving your ball.

This community recreation agreement is effective as of January 31, 2012.
